They will be entertained subject to condition that the candidates selected in the First Gauaraneed admission list has not been turned up for admission and vacancy is in existence.

The following requisite documents are required to furnish before the Admission Committee at the time of Counselling failing which your entitlement for admission will not be considered.

1. Marks Sheet and Original Certificate of Matric, Intermediate, Graduation and LL.B alongwith original CLC/DLC and Character certificate of the Last Course passed.
2. For getting benefit of reservation, The selected students must produce the certificate of category in which they belong. That Category certificate must be issued by the authority not less than in the rank of SDO.
3. A copy of admit card with Entrance result(MLET) as well as three passport size photo are also required.
4. The selected students are advised to keep photocopy of all requisite documents with hard copy of application form
5. The place of counselling is the University Department of Law situated in the campus of Patna Law College.
